CONDITIONS:

- The Clubhouse is available for hire by members and the public. Persons attending private functions as guests, are not required to sign the visitor's book.
- 2. The Clubhouse is available on Friday and Saturday nights between the hours of 5.30pm and midnight. However, Friday nights are on a share basis with members. Other times are at the discretion of the Management Committee.
- 3. A Venue Hire fee is payable in advance at the time of booking. No booking is considered confirmed until this agreement is signed and venue fee is received.
- 4. A cleaning deposit of \$100.00 is payable at the time of booking. The deposit will be refunded if all conditions of this agreement are met.
- 5. FMBC must be advised at the time of booking as to approximate numbers attending.
- 6. Use of the FMBC kitchen is on request for preparation of food only. ABSOLUTELY NO COOKING IS ALLOWED. Kitchen must be left clean.
- 7. The FMBC is licensed and the bar will operate upon request, NO BYO is permitted.
- 8. Special alcohol requests will be considered, however, at the end of the event any alcohol that has been specially purchased for the event that has not been consumed, is to be purchased by the Hirer at cost price.
- 9. Smoking is not permitted anywhere inside the building or on the verandah. The designated smoking area is located outside the building on the footpath.
- 10. Entertainment such as live music, karaoke etc is subject to approval and government noise restrictions (70db).
- 11. Decoration of the Clubhouse to suit the occasion is permitted provided no damage to FMBC property is incurred and decorations are removed prior to exiting the venue.
- 12. Damages to FMBC property, tables, chairs, glassware, etc are the responsibility of the Hirer and will be deducted from the deposit (this excludes wear and tear).
- 13. The Hirer is responsible for the good behavior and conduct of all guests.
