BACKGROUND

- a) The FMBC is an incorporated association. It operates facilities for its members from 375 Quay Street, Rockhampton. The FMBC has indemnity insurance of \$10,000,000.
- b) The FMBC's facilities include but are not limited to, the clubhouse, slipway, pontoons, launching ramp, yard storage, hard stands/maintenance yard and mooring buoys (the facilities).
- c) The member may from time to time use the facilities upon payment of relevant fees, if any, for their own private use and enjoyment subject to the FMBC Rules, Bylaws and Environmental Management Plan. NOTE: **No storage of private property is permitted** on the premises other than paid boat storage.
- d) In doing so, the member/applicant acknowledges the potential risk of damage and injury and agrees to the following.

AGREEMENT

- 1. In providing the facilities the FMBC makes no representation or warranty that the facilities are capable of performing a particular task or are suitable for a particular purpose.
- 2. Where the member intends to use the facilities offered by the FMBC for a specific purpose, the member before using it, will inspect the facilities to ensure that they are safe and suitable for the purpose intended by the member. This includes making such investigations and carrying out such tests to ensure the facilities are appropriate for the intended purpose.
- 3. The member acknowledges and accepts that the FMBC is not responsible for any loss or damage to the property of person of the member arising out of the use of the facilities.
 - The risk associated with the use of the facilities remains solely upon the member.
- 4. When using the facilities, the member will ensure the safety of others by taking such precautions, as should be taken, to maintain a safe environment. This includes, but is not limited to, supervising other persons.
